Note:

1. The Rules mentioned in Information brochure of Post Graduate Engineering Courses (M.E) for Academic year 2022-23 as displayed by State Common Entrance Test Cell, Govt. of Maharashtra will be followed.
2. Interested candidates should register their names physically along with required documents and registration fees of Rs. 800. Only registered candidates will be considered for **'Institute Level Counseling Round'**.

3. Documents required for Admission if seat is offered for admission:

- i) Print out of Final seat allotment letter or if seat is not allotted then final Merit Status for Admission which mentions Application ID and State General Merit Number issued by State Common Entrance Test Cell, Government of Maharashtra, OR Application form scrutinized by verification centre, OR Application form registered with the CET Cell duly verified by scrutiny centre.
 - ii) All Original documents of certificates as listed in Receipt cum Acknowledgement. If original documents are already submitted to any other institute, candidate has to produce certificate of document retention and Xerox copies of documents as listed in Receipt cum Acknowledgement.
4. Procedure of Counseling Round :
- i) Registered candidate and/or authorized parent must report personally at schedule date & time at the venue of admission center in institute.
 - ii) All the admissions will be strictly as per the merit list declared by State Common Entrance Test Cell, Govt. of Maharashtra.
 - iii) Candidates will be called as per merit number. If the candidate is absent or does not report for admission, he/she will lose the claim for admission. If the candidate is present and if the vacant seat is offered to the candidate as per merit, and if candidate is willing to seek the admission to offered seat, candidate has to pay entire admissible fees as applicable in the form of DD/Cash immediately on the spot. If the candidate fails to pay the entire fees, he/she may lose the claim of admission to the offered seat and the same seat will be offered to the other candidate as per the merit.
 - iv) The cancelled seat of this institute will be made available to other candidates as per merit, for admission during this counseling round.
 - v) The tentative vacancy position will be displayed at the time of start of counseling round. This being a dynamic round, the vacancy position for each branch may vary during the round.
 - vi) The admitted candidates will have to submit all requisite original documents before the date given by the institute, failing which the given admission may be cancelled.
 - vii) Venue for Registration and Counseling Round is VC Room, A Building of the Institute
