6. Co-Supervisor must be familiar with all SIU Ph.D. related rules and guidelines.
7. Co-Supervisor is not required to sign the six monthly progress report of the scholar. However, he / she will sign the final thesis before submission to the University.
8. Co-Supervisor will be nominated as co-author in publications emanating from the thesis.
9. As the Co-Supervisors are from the institutions not from SIU, the necessary formal approvals from the respective institutions are a prerequisite
